



## Share Repurchase Program 2007–2010

**via a Second Trading Line on virt-x**

On May 4, 2007, the Annual General Meeting approved the buyback of own shares of up to a maximum of CHF 8 billion of purchase value. On October 16, 2008, Credit Suisse Group terminated this program, having repurchased and cancelled a total of 49.7 million shares for CHF 4.1 billion, or 52%, of the approved CHF 8 billion.
